She reported that Moody's upgraded the issue to "AAa3" from "A1" and Standard and Poor reaffirmed the "AAA" rating. Also, the plan is to price the bonds around the week of October 21<sup>st</sup>. Ms. Samme Gee gave an overview of the Parameters Series Resolution. A copy was in the Board packet. MOTION: Moved by Ms. Swann; Seconded by Mr. John Miller; Passed unanimously.

RESOLVED, That the Series Resolution and documents presented to the Board, authorizing the Infrastructure Excess Lottery Refunding Bonds, 2024 Series A, be approved.

### **WDA EEGF PROJECTS**

Ms. Prezioso gave an update on the projects that are bidding and that needed to close by December 31, 2024. She also reported that the Legislature had passed a \$125 million-dollar supplemental EEGF appropriation in the Special Session.

Dear Ms. Prezioso,

The City of Nitro respectfully requests an additional \$250,000 in project overrun funding, supplementing the \$1,153,775 awarded in March 2024. Due to underestimated pre-bid costs for concrete, steel, general contractor conditions, and specialized equipment, alongside significant inflation impacts, the cur-rent funding is insufficient. The overrun will ensure project completion, with the City covering the remaining \$400,000 needed, \$250,000 of that will be in a low interest loan from the State of West Virginia.
